

# FY2021 KENTUCKY ARTS PARTNERSHIP PROGRAM

## How to use this rubric

Panelists will receive a copy of the rubric as a part of their panelist training materials. The rubric will be used to ensure as fair and unbiased a panel process as possible. The scoring mechanism defines each of the four criteria scored by panelists: Delivery, Networking and Collaboration, Diversity, and Value/Role of the Arts. Within each criterion, benchmark descriptions and corresponding point values.

Grant applicants can use the rubric as a guideline in completing their applications for the deadline.

### **Overall consideration for applications** (Panelists' overall application scores will reflect the following)
