

National Endowment for the Arts Arts Investment Fact Sheet March 2018

NEA Appropriations

- The \$149.9 million budget of the National Endowment for the Arts (NEA) represents just **0.004%** (four thousandths of one percent) of the federal budget.
- The NEA has already sustained significant budget reductions. The NEA appropriation is **12% lower than it was in 2010, a decline of \$17.7 million.**
- Each **\$1 in NEA grant funds leverages another \$9** from other public and private sources, resulting in \$500 million in matching support.

Everyone Benefits

- The NEA has an exemplary partnership with states. **Forty percent** of all NEA program funds—approximately \$47.7 million in fiscal year 2017—are distributed through state arts agencies and regional arts organizations. In combination with approximately \$360 million in state appropriations, **the federal-state partnership supports more than 23,000 grants in 16,000 communities across the United States.** Voters in every congressional district are stakeholders in sustaining this successful partnership.
- Combined, NEA and state arts agency grant awards reach **all 435 federal congressional districts.**
- NEA funding made possible more than 30,000 concerts, readings and performances and 6,000 exhibitions in 2017. More than **25 million individuals attended such live events** (exclusive of television and radio broadcasts).
- **The arts reach rural areas.** States use NEA and state legislative funds together to address the unique needs of rural areas. **Twenty-four percent** of state arts agency grants go to rural communities. Even larger proportions of grants and grant dollars go to rural areas in states with larger rural populations.


Impact of the Arts

- **The arts are a positive investment.** The U.S. Bureau of Economic Analysis reports that arts and cultural production contributes more than **\$763.6 billion** to the nation's economy. This equates to **4.2% of GDP**, which is greater than construction (\$739.9 billion) or transportation (\$546.2 billion).
- **The arts create jobs.** Arts and culture support **5 million wage and salary workers** and many more independent jobs.
- **The arts strengthen education.** [Research confirms](#) that the arts cultivate young imaginations and facilitate success in school, enhancing students' academic achievement in multiple subject areas. The arts provide the critical thinking, communications and innovation skills essential to a productive 21st-century work force.

NEA Funding to Kentucky: What's at Stake

- In its fiscal year 2017, the NEA provided **\$731,900 in Partnership Agreement funds to the Kentucky Arts Council**. These critical funds are used in conjunction with state legislative dollars to support grants and services across the entire state of Kentucky.
- NEA and state funds **enabled the Kentucky Arts Council not only to award 240 grants totaling \$1,617,031** in its fiscal year 2017 but also to provide non-grant services to arts organizations, community groups, schools and artists. These grants and services supported access to the arts, employment, arts education, community well-being and the cultural heritage of the entire state.
- Also affected by NEA budget cuts would be direct grants to arts organizations in each state. In its fiscal year 2017, the **NEA made 21 direct grants totaling \$485,000 in Kentucky**.
