

Letter from the Executive Director

Executive Director Kentucky Arts Council



I am constantly reminded that our people are our greatest asset. Every day, we see examples of Kentuckians doing extraordinary things and creating art that both amazes and inspires us - even amid great challenges. The word "resilience" became a motto we used to describe the character of Kentucky's arts and cultural community in 2023. In the aftermath of historic flooding in eastern Kentucky and destructive tornadoes in the western side of the state, our agency continued to aid in recovery efforts of the commonwealth's arts infrastructure even after initial humanitarian aid subsided. We put disaster relief grants in the hands of arts and cultural institutions and arts small businesses and developed a five-part disaster readiness, response and recovery series to help better prepare our arts partners, culminating in a national dialog with the National Assembly of State Arts Agencies (NASAA). Throughout the year, we endeavored to support continuing needs, share our experiences and best practices with other states, and ultimately move forward more prepared.

Resilience is more than overcoming adversity. It also means celebrating and sharing ways that the commonwealth is so much more than its darkest days. Kentucky is made up of diverse populations with incredible artistic traditions working in vibrant artistic communities, and the Kentucky Arts Council is committed to serving them. The traveling exhibit, "Continent to Commonwealth" reflects the Asian American and Pacific Islander (AAPI) culture that exists in the Bluegrass State. It featured the works of 31 artists who live in Kentucky and identify as AAPI individuals. Asia Institute–Crane House and the Kentucky Chinese American Association partnered with our agency to bring this important exhibit to Kentuckians and to highlight the cultures and artists who have contributed their work.

Speaking of important exhibits, the Governor's Derby Exhibit featured the theme of "Resilience" this year, and we were overwhelmed with more than 40 works offered for display in the Capitol Rotunda. People from all over the state submitted artwork that exemplified the resilient nature of our people and the talent that lies within our commonwealth.

In other triumphs, we had the honor of introducing Silas House as our state Poet Laureate during the Kentucky Writers' Day ceremony. Silas hit the ground running, elevating the literary arts of our state with his unique style and grace. House has connected his craft with positive memories of trips to Kentucky State Parks by offering onsite writing workshops and retreats. The powerful words from his poem entitled "Those Who Carry Us," spoken at the Governor's inauguration, will carry Kentuckians for years to come.

We also had the privilege of honoring nine new artists and organizations with the state's highest arts accolade, the Governor's Award in the Arts, at the historic Lyric Theatre & Cultural Arts Center in Lexington. Our United States Poet Laureate Ada Limón, winner of the national award, was among the recipients of a commissioned framed mosaic work by Kentucky Crafted artist Sebastian Duverge.

The Kentucky Arts Council looks forward to serving the commonwealth's artists and art organizations in coming years and spinning this time of "resilience" into future threads of strength and prosperity.

2022 Governor's Awards in the Arts

For the first time since 2019, the Governor's Awards in the Arts ceremony was held in-person in the Capitol Rotunda on Jan. 10, 2023. The commonwealth's highest artistic honors, the Governor's Awards in the Arts recognize individuals and organizations who have made extraordinary and significant contributions to the arts in Kentucky. Nine honorees celebrated outstanding achievement, either as artists or supporters of the arts. There was enthusiasm among the audience and deep gratitude from the recipients who received their awards and acknowledgements directly from Gov. Andy Beshear. The highlight of the event was a beautiful demonstration of the red cedar flute handcrafted by award artist Fred Nez-Keams. Although born and raised in a border town between Arizona and New Mexico on the Navajo Nation, Nez-Keams is pleased to have called Kentucky home for the past 17 years. Ranging from bright and dreamy, to haunting and sad, the sound of the storyteller flute filled the rotunda and brought a reverent tone to the celebration.

Poetry Out Loud

On March 1, 2023, the arts council hosted the Poetry Out Loud state championship at the Grand Theatre in Frankfort. It was the first time the high school poetry recitation competition was held in person since March of 2020.

Poetry Out Loud is sponsored by the Kentucky Arts Council, the National Endowment for the Arts and the Poetry Foundation. Each participating school receives an artist residency and the opportunity for the school champion to attend the state competition with a chaperone and bus subsidies to travel as a class.

Each student, in the first and second rounds, was judged on the recitation of two poems. The three top scorers from the first two rounds advanced to the final round where they each recited a third poem. The students, along with their teachers, selected the poems from a preapproved anthology of works.

Sarah Gamble of Allen County-Scottsville High school emerged as state champion with recitations of "The Albatross" by Kate Bass and "A Hymn to God the Father" by John Donne in the first and second rounds, respectively. In the third round, she recited "Candles" by Carl Dennis.

Gamble received \$200, and Allen County-Scottsville High School received a \$500 stipend for the purchase of poetry books.

Additionally, she represented Kentucky in the Poetry Out Loud National Semifinals in May 2023.

The Kentucky Crafted Market

After being off two years due to the pandemic and rolling out a smaller version of the show in 2022, the Kentucky Crafted Market returned in full swing to the Kentucky Horse Park Alltech Arena on March 10 through 12, 2023. In its 40th anniversary year, the Kentucky Crafted Market was restored with all the features visitors have come to expect – great visual art and craft, live music, hands-on activities and other rich artistic elements that come together to make this an annual event not to miss.

In addition to outstanding Kentucky-made visual art and craft, visitors enjoyed live music from The Market Stage, featuring performers from the arts council's Performing Artists Directory, a hands-on activities area for kids of all ages, a folk art demonstration area highlighting the mentor-apprentice relationship among contemporary Kentucky folk artists, and several Kentucky Proud food vendors.

More than 118 adjudicated members of the Kentucky Crafted program exhibited and sold their work at The Market, including 20 recently juried artists. The Market experienced its highest overall attendance since 2013, with more than 9,600 visitors, and one record single-business wholesale day with orders totaling approximately \$18,000.

In lieu of an admission fee, the Kentucky Arts Council asked visitors to donate to the Team Eastern Kentucky Flood Relief Fund. In that same spirit of healing and resilience, Kentucky Crafted artist Dan Neil Barnes surprised Appalshop with a replica of the Sun Quilt, a glass sculpture that was lost during the floods in 2022.

Kentucky Crafted Artists

Kentucky Crafted is an adjudicated program that assists Kentucky visual and craft artists through marketing and promotional opportunities and arts business training. Artists juried into this program are included in the Kentucky Crafted online directory and are eligible to exhibit at The Kentucky Crafted Market.

The Kentucky Crafted roster grew by 28 artists this year. Among them were Gail and Tim Lass of Waynesburg. The married couple work in different artforms, wood and glass respectively. They said they are honored to be among the best makers of art and craft in Kentucky.

"It means I've been accepted into a very elite group of people who do outstanding art," Gail Lass said. "It makes me feel that my artistic ability is worth selling. I have a product of good quality and being accepted into Kentucky Crafted reinforces that."

Tim Lass said the distinction makes him feel validated as an artist who veers away from convention: "I've never done anything very traditional. I've always been a little different than anyone else. Having my work accepted by the jury and a peer group as being high enough quality to become part of Kentucky Crafted is a tremendous boon to my ego. I'm honored to be part of Kentucky Crafted."

Kentucky Poet Laureate Induction and Kentucky Writers' Day

Gov. Andy Beshear appointed Laurel County native and award-winning author Silas House as Kentucky Poet Laureate for 2023 through 2024. "I've always felt that it's great to be part of Kentucky's literary tradition. I'm proud of that," House said of the honor. "Some of my favorite writers have been poets laureate, so that makes my appointment to the position extra special to me. I'm especially proud to serve under a governor I admire and respect so much," he added.

House is the nationally bestselling author of the novels "Clay's Quilt," "A Parchment of Leaves," "The Coal Tattoo" and "Eli the Good." In 2012 he coauthored "Same Sun Here" with Neela Vaswani. House's most recent novel, "Lark Ascending," was published in 2022.

As an openly gay man, House said he is proud to represent the LGBTQ community as poet laureate, but added that there are many facets to his life with which he hopes others will connect.

"When you go in and say, 'I'm these things,' there are a bunch of young people out there who have not seen themselves represented in public," House said. He added that he is proud of his working class Appalachian background and hopes others who share the various intersections of the communities he represents will be inspired.

"When you see yourself represented, especially in a positive way, that really matters. I'm a working class, rural, Appalachian, gay person of faith," he said. "But more and more I see people reducing someone's identity to an absolute. One thing I'll always talk about is that we have to stop thinking in absolutes and start thinking of people as more complex.

"You can't have true empathy if you reduce people to either saints or monsters."

Kentucky Poet Laureate Induction and Kentucky Writers' Day

House was inducted as poet laureate in a ceremony on Kentucky Writers' Day, April 24, in the Capitol Rotunda in Frankfort. Kentucky Writers' Day is celebrated annually on or around April 24, the birthday of Guthrie, Kentucky, native Robert Penn Warren, the first United States Poet Laureate. In odd numbered years, the governor appoints a poet laureate to a two-year term. That person acts as Kentucky's literary ambassador, leading the commonwealth in a variety of literary activities and events throughout their tenure.

The 2023 Writers' Day celebration featured readings and remarks by House and outgoing Kentucky Poet Laureate for 2021-22 Crystal Wilkinson. That afternoon, Paul Sawyier Public Library in Frankfort featured additional activities with readings by House, Wilkinson and former poets laureate Richard Taylor, Joe Survant, Sena Jeter Naslund, Maureen Morehead, Frank X Walker, George Ella Lyon and Jeff Worley.





Governor's Derby Exhibit

When the winds calm and the waters recede, the roots and the rocks will prove their resiliency.

The Governor's Derby Exhibit adorned the Capitol Rotunda from May 5 through May 18. With the theme of "Resilience," pieces in the exhibit illustrated scenes, stories or themes that reflect the capacity to withstand, recover or overcome. The exhibit showcased the work of 48 artists from across the commonwealth.



Continent to Commonwealth

The Kentucky Arts Council, in partnership with Asia Institute–Crane House and the Kentucky Chinese American Association, invited Asian American and Pacific Islander (AAPI) Kentuckians to share their visual art. Dozens of artists answered the call, with ethnic identities including Korean, Filipino, Japanese, Chinese, Taiwanese, Indian, Vietnamese and Karen, an ethnic group connected with the land now known as Myanmar, formerly Burma. A panel of Asian and Asian American cultural specialists selected artworks to include in this exhibit, which they named Continent to Commonwealth.

The exhibit debuted during Asian American and Pacific Islander Heritage Month, May 2023, and is scheduled to travel statewide through mid-2024. The purpose is to share AAPI experiences in the commonwealth today, and recognize the artistic expressions that Asian individuals, families and communities contribute to Kentucky's cultural landscape.

Creative Industry Summit Series

The Kentucky Arts Council regularly offers online learning experiences designed for artists, arts organizations and anyone working or aspiring to work in the creative industry. In 2023, webinars and online panels revolved around the themes of diverse artistic communities in the commonwealth, disaster relief and preparedness, and celebrating National Arts and Humanities Month. Disaster Relief and Recovery Grants

Seven months separated two of the worst weather-related disasters in Kentucky history, both resulting in significant devastation and loss for the arts community. On Friday, Dec. 10, 2021, a violent, long-tracked EF4 tornado moved across western Kentucky, damaging several towns, decimating others, effectively wiping them off the map. Later the following summer, a 1000-year flood submerged eastern Kentucky and central Appalachia.

Precious and exceptional examples of quintessential Kentucky artworks and art forms were lost or damaged. In Mayfield, a mural by nationally renowned folk artist Helen LaFrance was among what little remained of St. James African Methodist Episcopal Church. The Icehouse, home of the Mayfield Graves County Art Guild was demolished. In eastern Kentucky, worldfamous Appalachian media and cultural institution, Appalshop, was underwater along with its irreplaceable archives, while in Hindman, mountain dulcimers floated down a dangerously over-brimming Troublesome Creek.

In each instance, the Kentucky Arts Council made calls to artists and arts organizations, documenting loss, visiting sites, assembling federal resources, and most importantly, checking on our friends. We combined our own funding, some from the NEA, and some from our partners at South Arts to award disaster relief funds to organizations, schools and working artists. The KAC continues to emphasize the importance of disaster preparedness through education and convenings. Furthermore, we have been national leaders in advocating for the availability of monies for arts asset recovery and relief in the wake of disaster. The final chapter of these stories is not one of devastation, but one of resilience and Kentucky's determination to be prepared and persevere amid loss.

Folk and Traditional Arts Apprenticeships

The Kentucky Arts Council awarded \$24,000 in grants — \$4,000 each — to six traditional and folk artist mentors who spent a year teaching skills and practices vital to the state's cultural heritage to apprentice artists working in the same art form.

The arts council's Folk and Traditional Arts Apprenticeship Grants facilitate and support the recognition and continuation of Kentucky cultural traditions. Funding allows apprentice artists to study face-to-face with mentors in their field to advance toward mastery within a specific folk-art community.

Kentucky Arts Partnerships

The Kentucky Arts Council awarded more than \$1.1 million in operating support to 100 arts organizations in 32 counties across the commonwealth through its Kentucky Arts Partnership (KAP) program.

The KAP program provides nonprofit arts organizations with unrestricted operating support to ensure that year-round participation in the arts is available to the people of Kentucky.

The competitive grant process funds applicants based on operating revenues, a panel review of applications, and funds available for the program. New to the 2023 grant cycle, Kentucky Arts Partnership grantees were required to provide a cultural equity plan detailing their strategies for assessing and implementing diversity, equity, access and inclusion into their organizations' policies, procedures, programming, and overall culture. KAC recognized that each organization may be at a different point in this process. Some organizations were just recognizing the need for a plan, while others were already evaluating a previously implemented plan. The aim of this requirement was to meet each arts organization where they currently stand by rewarding responsible processes in the initial plan and significant progress as described in the reporting intervals and subsequent KAP applications. Kentucky Peer Advisory Network consultancies were available to assist organizations in meeting this new requirement.

With 97 of the 100 organizations reporting, KAP organizations collectively employed 544 full-time workers, 557 part-time workers and 3,445 independent contractors in the 2023 fiscal year. The organizations together provided more than 3.7 million in-person arts experiences at events that occurred during the fiscal year, which includes individuals who had multiple experiences at one or more venues. These organizations collectively contributed \$1,308,623 in state, \$4,505,664 in federal and \$459,731 in city and county taxes and leveraged arts council funds to help generate more than \$83 million in revenue.

The fellowship can only be awarded to any individual twice in their lifetime. In calendar year 2023, the arts council awarded fellowships in literary arts – fiction, creative nonfiction, poetry and play/screenwriting.

Fellowships award excellence, but also support artists in professional and artistic growth. Recipient Megan Pillow is currently working on a novel she is developing from a short story she wrote, titled "Long Live the Girl Detective," that appeared in the publication Electric Literature. The Individual Artist Fellowship will allow her to make significant progress toward finishing it, she said.

"It's huge for me, because writing is often not well paid, especially creative work, and it's hard to get funding for creative work," Pillow said. "I work full-time, I'm a single mom and I work my schedule around my kids' schedule. This fellowship will allow me to dedicate funds to childcare so, in addition to my full-time job, I'll have time to finish working on this novel."

In addition to the Individual Artist Fellowships, the arts council awarded four Emerging Artist Awards, \$1,000 unrestricted grants to early-career, professional Kentucky artists who demonstrate excellence and creativity in their work.




About Us
